#### **Loxnet Competition Terms and Conditions**

# §1. General Provisions.

- The Competition called "Loxet Competition" ("Competition") is organized by KISS digital Sp. z o.o. with registered office in Kraków, entered into the Register of Entrepreneurs kept by the District Court Kraków-Sródmieście in Kraków, XI Commercial Department of the National Court Register, under no. KRS 0000435987, with a share capital of PLN 50,000, NIP (Tax Identification Number) 6751479294, Statistical Identification Number REGON 122627871, herewithafter called the "Organizer".
- 2. The Competition will be run from 31st March, 2015 up to and including 31st April, 2015. The Competition may be terminated before 30th April, 2015 if the Competition winner is decided before that date. In such case the Organizer shall inform about the Competition termination at the web site loxet.io
- 3. Organizer employees, employees of the Organizer partners and other individuals participating in organization of the Competition shall be excluded from participation in the Competition. The aforementioned exclusion covers collaboration, both direct and indirect, between the Organizer and the third parties, regardless of its form (written or oral) and includes, but is not limited to, the employees and partners of the parties having the status of the Patron of the Competition.
- 4. Competition participant must be a natural persons, have reached the age of majority, must have full legal capacity and live in Poland (hereinafter "Participant").
- 5. The Organizer is the controller of personal data provided by the Participants in the Competition.
- 6. The Organizer informs that the personal data of the Participants in the Competition may be processed by the administrator of Facebook as provided for in the Terms and Conditions of this service available at the following URL address: http://pl-pl.facebook.com/terms.php?ref=pf.
- 6. The participation in the Competition shall be construed as equivalent to the consent of the Participants in the Competition to have their personal data processed by the Organizer for purposes related to the Competition.
- 7. The Participant in the Competition is entitled to inspect the contents of personal data provided, amend them, or remove the aforementioned data.

# §2. Rules of the Competition.

1. The Participants in the Competition should solve the problem consisting of remote (i.e. without direct physical contact) opening of the VOLVO 480 car (hereinafter: Car) that is parked in Krakow, at the car park at 14 Straszewskiego street, in accordance with the conditions set out below.

- 2. The Car shall be protected by the Organizer with Loxet device and application. During the Competition, the Loxet application shall connect to the device installed in the Car and shall open and close the doors in the Car every 10 (ten) minutes. The Participant's task is to remotely open the Car (when the Car is closed by Loxet application and device) using any application other than Loxet and Participant's electronic devices.
- 3. While performing the task, the Participant must not use any devices or tools that breach the physical protection of the car; in particular, it is forbidden to: break locks, smash car windows and any physical interference in the Car during opening. The task consist of remote opening of the Car using the radio signal (Bluetooth) and connecting to the device installed in the Car to open the doors.

### §3. Deciding the Winner of the Competition. Prize.

- 1. The winner of the Competition shall be the Participant who:
  - a. shall open the Car in presence of the Organizer and disclose to the Organizer all details of the application used to complete the Competition task (including the source code and the technical description) and the devices used, or
  - b. shall transmit to the Organizer the application (with source code and the technical description), which allows for opening of the Car according to the terms described herein.
- 2. The prize in the Competition is a VOLVO 480 car, registration number STA6H69 worth 2000\$ (with the applicable prize tax).
- 3. The Organizer may announce the information that the winner of the Competition has been decided by publishing it at loxet.io website and shall transmit this information to the e-mail address indicated by the Participant.
- 4. The prize shall be collected at the registered office of the Organizer. Should the prize be not collected by the winner of the Competition within 14 days from sending the information to the e-mail address indicated by the Participant, the right to the prize expires. Upon collecting of the prize, the Participant transfers to the Organizer all rights to the information and/or application (with the right to use the source code and the technical description), that has been mentioned in point 1 above.
- 5. The prize may be collected as detailed in this Terms and Conditions only, and it is not possible to collect the prize equivalent in cash nor to exchange it for another material prize. Shall the winner of the Contest not have Polish citizenship, the winner will have the right to substitute a prize for cash in the amount of US\$ 2,000 (two thousand dollars).
- 6. Prize tax, if any, shall be paid by the Organizer.

- 7. The prize may be awarded only in case if the winner has met all the conditions arising out of these Terms and Conditions.

- 9. The complaint mentioned in point 8 will be dealt with within 14 days from the date of receipt by the Organizer.
- 10. The Organizer shall notify the Participant about the way the complaint shall be dealt with to the e-mail address of the Participant submitting the complaint.

#### §4. Final Provisions.

- 1. By entering the Competition, the Participant agrees to the terms of these regulations and agrees to receive from the Competition Organizer any information necessary to run the Competition.
